## IPM statement

It is the goal of Point Arena Schools (Point Arena Joint UHSD/Arena Union SD) to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

Our pest management goal is to control/eradicate pests to ensure student and staff safety in a healthy learning environment.

## Pest identification, monitoring and inspection

Pest Identification is done by: school district staff; pest control business contacted as needed for ants and other pests

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Maintenance Director and Maintenance II staff and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

Maintenance/custodial staff uses a work order form to notify the Maintenance Director of any pest issues they discover in the course of performing their duties. Teachers and support staff may also submit a work order for pest problems. The Maintenance Director is responsible for contracting a pest control company to treat the pest problem.

**Chemical pest management practices**

If non-chemical methods are ineffective, the school district will consider pesticides only after careful monitoring indicates that they are needed according to pre-established action levels and will use pesticides that pose the least possible hazard and are effective in a manner that minimizes risks to people, property and the environment.

This school district expects the following pesticides (pesticide products and active ingredients) to be applied during the year. (This list includes pesticides that will be applied by school district staff or licensed pest control businesses.):

Advion Ant Gel - applied by Orkin Pest Control Services when no other remedy has corrected the problem

Maxforce Hydromethalon - applied by Orkin Pest Control Services when no other remedy has corrected the problem

**Training**

- School IPM training course approved by the Department of Pesticide Regulation (Education Code Section 16714; Food & Agricultural Code Section 13186.5).

**Submittal of pesticide use reports**

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt<sup>1</sup> from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at [www.cdpr.ca.gov/schoolipm](http://www.cdpr.ca.gov/schoolipm). (Education Code Section 16711)

<sup>1</sup> These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
