Section 7: DISCUSSION

7.1 Prop. 39 Update (Pg. 94)

Superintendent Cushenbery gave an update about the Prop. 39 projects stating that, energy efficient broilers will be installed at both the high school and elementary school by workers from IES in the upcoming week. Superintendent Cushenbery also reported that the lighting upgrades will be complete by the end of May.

7.2 LCAP Update

Superintendent Cushenbery reported that an employee from MCOE will be at the District Office to review the new LCAP Reporting format with Principal Carson, Business Manager Chin and him.

7.3 Career Readiness – Dream It, Be It: Pathway to Opportunity Program (Action Network)

Board President Robinson announced that Acton Network was unable to be at the meeting. The item will be placed back on the May Agenda.

Board Member Shimon spoke about college readiness for students at Point Arena High School and asked what is being done to help students prepare for a careers path who are not on the college path? Board Member Shimon stated he didn't believe the District is doing as much as they need to for career path students. Board President Robinson stated she attended a Santa Rosa Jr. College visitation and at that time they were told there were many Certificate Programs available for students through SRJC. Superintendent Cushenbery stated that an advertisement went out in the ICO inviting folks to sign up for the SRJC programs but they were unable to meet the minimum 15 student enrollment requirement. Superintendent Cushenbery informed the Board that the CTE teachers at Point Arena High School are working on a Certificate Program for students at Point Arena High School. Superintendent Cushenbery will invite our CTE teachers to the next Board Meeting to speak about the Certificate Programs being offered.

7.4 Infant Care Program for Point Arena Schools employees (Pgs. 95-99).

Superintendent Cushenbery informed the Board that he looked into locations to house the Infant Care program, should the Board approve the program, and a consideration was to house the program on the Arena Union Elementary School campus. Superintendent Cushenbery said the room is very bright and amenities are close by. Superintendent Cushenbery will meet with Business Manager Chin to review budget costs.

7.5 WASC Visiting Team Report and Final Presentation (Pgs. 100-143).

Superintendent Cushenbery informed the Board that the WASC report is on the District's website and that the staff will work on a follow-up WASC report.

• Benchmarks

Superintendent Cushenbery asked Principal Carson to make his Academic Support report, while he set-up his presentation.

Principal Carson reported that one of the hurdles in making the assessment data more readily available is that the online component of the two new adoptions, *ConnectEd*, does not interface with *Illuminate* which has been their student data system. Teachers have to manually enter the data to *Illuminate*. For the K-2 teachers, they fill in bubble sheets from the students answer sheets and scan those bubble sheets to upload into *Illuminate*. For the 3rd to 6th grade students, the teachers have the students put their answers first on the actual tests and then have the students transfer their answers to the bubble sheets. By way of contrast the

Middle School teachers in Social Studies and Science, because they don't have new adoptions yet, have assessments within *Illuminate* that the students can take online. Principal Carson reported that they are looking into the possibility of putting all of their assessments into *Illuminate* to have the ability to have all students be able to take their assessments online once they are able to use a keyboard.

Principal Carson had distributed his Benchmark report to the Board and briefly reviewed it (see attachment).

Superintendent Cushenbery reviewed some of Point Arena High School Benchmarks and compared assessment data for reading and math. Superintendent Cushenbery stated that the two reading programs that are being used for those students who are struggling in reading are; *Read Live* and *Read 180*. He stated that they will use *Read 180* once again in the 2017-18 school year.

BP/AR 5148.2, Before/After School Programs (Reflect New Law which pertains to charging a fee for participation in an ASES, 21st CCLC, or ASSETS program, as long as the fee is waived or reduced for low-income families).

BP 6111, School Calendar (Updated to clarify that a district must offer a min. of 175 instructional days per school year until it meets or exceeds its funding target under the LCAP formula).

BP 6117, Year-Round Schedules (Updated to clarify that a year-round school is required to offer a minim. of 175 inst. Days per school year until it meets or exceeds its funding target under the LCAP formula).
