



**MENDOCINO COUNTY YOUTH PROJECT  
Prevention & Early Intervention (P.E.I) Services  
CONTRACT FOR SERVICES**

This is a contract for services between the Mendocino County Youth Project (MCYP) and Point Arena Union School District. This contract is for the period that begins September 1, 2017 and ends June 30, 2018.

**CONTRACT AMOUNT: \$16,424.**

**MCYP will provide 7.5 hours of MFT Intern professional services per school week, for 10 months. The MFT Intern will receive 1 hour of Clinical Supervision weekly.**

**The Marriage Family Licensed Therapist Intern (ISIS) will:**

- Provide 5.5 –6.0 hours of services on campus, one day per week as assigned. .
- The services will include direct counseling services to students and the attendance of meetings that support the services provided to students.
- An additional 1– 1.5 hours (7.5 total) may be utilized in professional duties supportive of the direct services.
- Adjust their work schedule accordingly if they exceed a total of 7.5 hour's work in any week, and will advise the school of this adjustment to the work schedule.
- Notify the school district of any work related absences. Absences from weekly services will be related to utilizing benefited sick time, and work related trainings. School based Therapists are encouraged to use their paid vacation time during school breaks.
- Meet with the designated school contact and staff regularly in relation to duties provided.

**The MCYP Clinical Director (Mimine Ambrois, LCSW) will:**

- Provide Clinical Supervision for support, ongoing education, preparation, and travel time.
- Maintain contact with the school in coordinating the agreements of this contract.

**Point Arena Union will:**

- Fund the MFTI position for 7.5 hours and Clinical Supervision for one hour per week for the ten month contract.
- Provide confidential space for the MFTI to meet with youth one on one and in small groups.
- Maintain contact with MCYP regarding the professional services provided on campus.
- Complete an annual survey to provide MCYP relevant feedback on services provided to students.

*The MCYP shall defend, indemnify, and hold harmless the Parties to this Agreement and their officers, agents, and employees from all liability for any loss, damage or injury to persons or property, including attorney's fees and costs, arising out of or attributable to the furnishing of services by MCYP pursuant to this agreement.*

*When signed by all parties, this document will serve as a contract between MCOE, and MCYP. It is our understanding that payment of \$16,424. for the MFTI school based services will be made to MCYP in 10 equal monthly installments. MCYP will provide an accounting of services delivered, at your request. This contract may be terminated with a 30 day notice by either party and may be modified with agreement between both parties.*
