**DRIVER TRAINING MEMORANDUM OF UNDERSTANDING BETWEEN
POINT ARENA SCHOOLS DISTRICT AND
CALIFORNIA RURAL INDIAN HEALTH BOARD
MANCHESTER – POINT ARENA HEAD START PROGRAM**

THIS MEMORANDUM OF UNDERSTANDING AGREEMENT is entered into for the 2021-2022 school year between the California Rural Indian Health Board, of the State of California, hereinafter referred to as “CRIHB”, and the Point Arena Schools District, of the State of California, hereinafter referred to as “Point Arena Schools”.

WHEREAS, Point Arena Schools will assist in providing CRIHB Head Start Program drivers with mandated driver training hours.

WHEREAS, if the CRIHB driver joins in on a driver training session already being held by the Point Arena Schools’ Transportation Director with Point Arena Schools’ bus drivers, and the training session occurs on a Point Arena Schools’ Transportation Director contract day, there will be no monetary charge between Point Arena Schools and CRIHB. Point Arena Schools will provide the CRIHB Director with a list of Transportation Director Contract dates prior to joining the trainings for approval by the Head Start Director, for the Head Start Bus Driver(s) to have the opportunity to join trainings already being held.

WHEREAS, if the CRIHB driver joins in on a driver training session already being held by the Point Arena Schools’ Transportation Director with Point Arena Schools’ bus drivers, and the training session occurs on a non-contract day (with prior approval by the Superintendent), then the CRIHB Head Start Program will reimburse Point Arena Schools for the pro-rata share of the Point Arena Transportation Director’s salary and benefits for the time expended for the training session.

WHEREAS, if the Point Arena Schools’ Transportation Director expends time to solely train CRIHB drivers only (with prior approval by the Superintendent), then CRIHB will reimburse Point Arena Schools for the full amount of the Point Arena Schools’ Transportation Director’s salary and benefits for the time expended for the training.

TERMS

This agreement becomes effective, July 1, 2021 and will continue to June 30, 2022, to be renewed the following school year if both parties agree. Point Arena Schools will bill CRIHB for any amounts incurred.

CANCELLATION

This agreement may be canceled by either party upon the giving of thirty (30) days written notice to the other party.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement to be in effect for the period of July 1, 2021 – June 30, 2022.
