Superintendent Galletti congratulated the graduates and thanked the staff. Galletti gave an update on the building projects; The PAHS Library roofing bids closed today and removal of the buildings at Arena will close tomorrow. If the City of Point Arena chooses to use one of the condemned classrooms for their use it will reduce the removal bid price by approximately \$14,000. The Board will need a Special Meeting in July to approve the bids and also ratify the CSEA Agreement.

5.4 Arena Union Elementary Principal

Michelle Egger reported 9 students are attending the Extended School Year (ESY) from 9:00 AM -12:00 PM, M-F. Transportation and lunches are provided and kids are happy to be there. ESY is for students in grades K-12 who have it written into their IEP's. There are no high school students attending this year.

5.5 Point Arena High School Principal

Principal Wilkes thanked the 4 board members who attended both the South Coast Continuation and Point Arena High School graduations. Three High School students have passed the ELPAC and can now take another elective in place of the ELD program. 16 students had a 4.0 at second semester, which is more than 10% of the enrollment.
