This plan was presented at a public hearing at the District's Board of Trustees September 2021 board meeting for stakeholders, including parents, teachers, and school staff to discuss and provide any feedback with the purpose of promoting plan involvement prior to the plan adoption at the October 2021 board meeting (in order to meet the Oct. 29 deadline). The district also collaborated with site Principals in order to gain their insight on the plan, where the Principals further discussed with their staff and other stakeholders. In addition, the district held a separate community meeting with community stakeholders, comprised of administration, board members, certificated and classified employees, and parents to discuss and gain feedback on the plan.

Based on the community stakeholder meeting, public hearing and board approval meetings, and any feedback provided during those gatherings, the Plan was adjusted and revised to meet the needs of the district and to maintain compliance with state and local health orders. At the board meeting public hearing, one trustee asked a clarification question – wondering if the funds are separate, with an allocation for AUESD specifically, and a separate allocation for PAJUHSD specifically, within our one district budget. Superintendent Galletti confirmed that this is correct, and that the plans reflect the separate allocations with one plan for AUESD and one plan for PAJUHSD. Further, although specific requests to adjust the plan were not voiced at stakeholder meetings (ie. Site Council, ELAC/DELAC, and NAEAC), the general takeaway from the discussions that took place were to provide services for our most vulnerable students, thereby promoting mental health counseling, ELD targeted support, special education services such as one-on-one SPED support, and any items or services necessary to foster thorough health standards. Therefore, the district ensured that these items and services were included in this ESSER III Expenditure Plan.

# **ESSER III Expenditure Plan Instructions**

### Introduction

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
