Section 5: BRIEF REPORTS

5.1 Student Board Member

Student Board member Sydney Regelbrugge reported on athletics, college classes, scholarship applications, the Valentine's Day Dance, and successful home game concessions earning money for the classes. The Theater class is performing "Almost Maine" tonight and Friday, and there will be a band concert in May.

5.2 Board of Trustees

Member Visher acknowledged the fire at the Gualala Community Center, and she attended the South Coast Continuation graduation last Friday. Member Gardiner acknowledged the PA Athletic department. President Hillscan also attended the South Coast Continuation graduation, and visited PAHS and plans to visit AE.

5.3 Superintendent

Principal Egger gave Superintendent Galletti's report as he was away with the boys basketball team in Freemont for a playoff game. Staff attended the H.E.R.O intruder on campus training on January 25 and there will be a follow up training in March; a deputy from the Sherriff's department will attend. "Jump Start" at Arena will extend to at least 3 weeks, as part of the Summer Learning Program, and will include enrichment programs through Action Network and a Jr. Lifeguard Training. Principal Feliz added Point Arena High will offer Algebra to help transition incoming 8th graders, opportunities for credit recovery on site and remotely this summer through Edmentum, and enrichment. The Extended School Year (ESY), a 4 week program for students who have it written in their IEP, will also be offered.

5.4 Arena Union Elementary Principal

Principal Egger thanked Josh and Monica Oropeza for starting a basketball program for 3rd through 5th graders, with games against Horicon. Middle school is playing basketball, gymnastics will be offered in the after school program, middle school softball is starting, and potentially middle school soccer in the spring. Athletics are driven by academics; students need to keep grades up to participate. A small group of students attended the Valentine's dance, there is no school during President's week next week and Site Council will meet tomorrow at 4:30 in Library and on zoom. Site Council is looking for new members.

5.5 Point Arena High School Principal

Principal Feliz reported the Pirates self-defense course will launch after break during 7th period with a local instructor and Isis as the teacher on record. Staff and students took a field trip to Mendocino High where they have had a \$160K radio station in place since it was an ROP class and their instructor agreed to consult with PAHS. Students will air their podcasts on Pirate Radio and *monitored* playlists. CTE grant money will be used for the Radio program.

The WASC focus is on how teachers can promote expert learners; MCOE is helping with Guided Language Acquisition Strategies (GLAD) and Universal Design for Learning (UDL) Strategies, which dovetail in with The New Tech Network (NTN) Project Based Learning (PBL). Teachers are evaluating themselves and watching their colleagues as part of the WASC process. Mr. Feliz thanked the county and board for their support.

5.6 AUTO

Teacher Kelly Gaona, 1st grade teacher, welcomed the new board members and shared reports from teachers K-8 on what students are learning. The Science and Engineering Fair will start on March 3 in the

Arena Multipurpose room, 6th and 8th grade classes are planning to kayak on the Gualala River to learn about the watershed and will go tide pooling to learn about the intertidal zone.

5.7 PAHSTA

Aaron Krogel, English Teacher at Point Arena High, shared reports from the English, History, STEM, Science and Math teachers. Auto shop class is working on parent and staff cars. Radio class is learning broadcast skills and how to produce a show. The February 16 band concert is cancelled; the May 4th concert will be fabulous. The first annual Coast Band Day will be on March 30th at Point Arena High School, where the PAHS band will join with the Fort Bragg High School Band. On April 6th the Fort Bragg middle school band will join the Arena middle school band.

The Drama class is performing "Almost Maine" tonight in the auditorium and on Friday for the school.

Section 6: DISCUSSION

- 6.1 Student Achievement Semester Grades
 - Point Arena High School

Principal Feliz presented a breakdown of Semester grades by GPA and grade level. Data shows where interventions are most needed. All seniors have above a 2.0 and they will benefit from the dual enrollment program.

• Arena Union Elementary

Principal Egger shared data from Arena's first and second quarters. 6^{th} , 7^{th} and 8th grade students all have grades above a 2.0 with high percentages of students in the 3.0 - 4.0 range. Arena works with students to get all their work in before the end of the quarter and promotes academics and athletics.

6.2 Special Education Report – Marc Feliz

Principal Feliz shared his report on students with disabilities and program offerings: we are using a "Continuous Improvement Model" from MCOE and are part of the Mendocino County Schools SELPA (Special Education Local Plan Area). From the 2016-17 school year through 2022-23, students with disabilities have increased from 13.6% of students to 16.3% and Feliz predicts it may increase to 20%. The disproportionality of EL students receiving Special Ed Services has been improved, and the highest percentage of all students with disabilities is in specific learning disabilities. Interventions include a multi-tiered system of supports to make sure students get what they need.

6.3 WASC Report – Marc Feliz

Lillian McFarland, PAHS WASC coordinator reported that all high schools and colleges on the west coast must have WASC (Western Association of Schools and Colleges) accreditation. Ms. McFarland distributed copies of the WASC Self-Study Report and shared their Mission and Vision statements and the "Student Learning Outcomes" with the acronyms – "ARRticles": Authentic, Respectful, Responsible. The two areas of follow up from the last WASC visit are the NTN program with standardized school benchmarks and continue school administration and teacher peer observations. McFarland shared the goals and school wide action plan, asked for board member participation (Board President and Board Clerk) and shared this has been a multiple year collaborative effort.
