Howard Cole, Science Teacher/Technology Director, reported on work during the summer: internet switches have been replaced at both schools and 27 security cameras with 38 terabytes of memory, which can record both audio and video, have been installed at the Arena Elementary campus. Point Arena High School has purchased 75 new chrome books for students and new "owls" will be used to amplify virtual meetings.

## **Section 4: BRIEF REPORTS**

4.1 Arena Union Elementary Principal

Principal Egger shared 18 kids attended the Extended School Year (ESY), and the 3 week "Jump Start" program for students in grades 1-5 averaged 16 students. Matt Kramer has been hired to teach 4th grade and brings 16 years of Elementary school experience. 5th grade classes will be split between Lauren Jones, who will teach Math and ELA, Justin Hughey, Social Studies, and Kristin Allen will teach Science. Julia Binnings will fill Roy Moua's place. Tansy Liester will teach Kindergarten; she needs a few more classes for a certificate to teach TK. The middle school playground equipment is ordered.

4.2 Point Arena High School Principal

Principal Feliz shared 13 students attended the summer "Targeted Intervention" for English and Math and 20 students went through credit recovery using Carnegie. Carnegie has multilingual speakers and 35% of our EL learners were reclassified last year. Ms. Mazza will be teaching Marine Science Technology through NOAA and will be going off campus 1<sup>st</sup> and 7<sup>th</sup> periods. Students will use drones as part of the curriculum. Career Pathways will offer a work based learning experience and PAHS is now a CTE school.

Student Board member Sidney Regelbrugge reported fall sports practices have started and students are waiting for their Academics schedules and the "college on campus" options.

Board member Gardiner attended a Policy Committee meeting and has looked at the Accountability tutorial for elected officials and the Ethics Training, sent from Dunnell, due Sept. 28. Member Visher shared the Sea Ranch Foundation raised money to pay for scholarships to The Sea Ranch Summer Camp; 20% of attendees were local kids on scholarship. Mendonoma Health Alliance (MHA), two teachers from Arena, Four Eyed Frog and EduAct all came together to offer tutoring to seven 2<sup>nd</sup> grade students. The five tutors saw students at the Coast Community Library, Four Eyed Frog bookstore or MHA. Students saw measurable growth and are now well prepared for 3<sup>rd</sup> grade.

Member Wilder commented on the many activities available for students during the summer. Member Aparicio shared his kids have enjoyed what Action Network offered and the tribe loaned their van out for the field trips; communities came together to benefit all. Board President Hillscan reported PCCS offered a summer learning program with weekly themes for the 12-15 kids attending. Hillscan attended the first facilitated equity meeting and a Policy committee meeting. The policies on this agenda are the first read and will be voted on next month, giving time for comments before the vote.

# 4.7 Superintendent

Superintendent Galletti shared there were tremendous opportunities for students during the summer, and with Action Network offering at least 30 – 9 hour days we were able to use ELOP funds. PAHSTA and AUTO are in the process of unifying into one teachers union, which will take a lot of work this school year to merge the contracts and agree on common language. The Equity committee met today with Shane Hildebrand and will meet again on Sept. 5 and Sept. 26. Hiring is a challenge; not one district in Mendocino County is fully staffed. We have a solution for the 5<sup>th</sup> grade teacher vacancy and a plan for the music program. Sue Bohlin will offer music 2 days per week for 3 periods. Galletti met with Point Arena City Manager Paul Andersen to talk about partnering on a housing project on school property. City Council will decide at their August 22, 2023 meeting if they want to partner with us. State Parks may join the partnership and they may have property for housing. Galletti will reach out to McGuire's office for information on affordable housing; 3 new bills have gone into effect to expedite the process. The Facility committee will be involved as well.

# 5.2 9<sup>th</sup> grade graduation rate

Principal Feliz reported on the graduation rate; this cohort started with 41 freshman in 2019-20. PAHS exits students when they leave to not be held responsible for their graduation. In 2020-21 there were 40 (one student went to South Coast), in 2021-22, we went down to 31, (10 kids went to Mendocino) in 2022-23 there were 27 students who graduated, leaving an 88.9% grad rate. State graduation rate is 87%. The final report is out after August 25. We keep track of students in Calpads. Data demographics are not broken down since the number of students is below 100. Marc will provide that data to board members if they request it.

Member Aparicio, asked when Native American Curriculum would be implemented. It is not required by the State and there is no timeline. Mr. Galletti said there could be pieces of the curriculum this year but it will take time to develop. Member Martinez said Washington State leads the country with their Native American curriculum; it is a nice starting block for admin and teachers to develop lesson plans and he recommends working with local tribes to bring local tribal history into the classroom. Martinez requests we adopt the "Since Time Memorial" outcomes from the curriculum. Principal Feliz shared PAHS plans to bring the "While Bison" Pomo Language curriculum from Lori Laiwa as a second language course. The current ethnic studies class covers local land rights. NAEAC is the committee to figure out the curriculum piece; they can modify Washington State curriculum to match our local tribes. Washington has 26 tribes, CA has 109 tribes. Member Visher will research the Washington Curriculum and provide a write up to the committee, who will narrow it down for discussion. Members Aparicio, Bechtol and Martinez will serve on the committee and will meet with Warren to refine the Policy.
