## MEMORANDUM OF UNDERSTANDING BETWEEN ACTION NETWORK AND POINT ARENA HIGH SCHOOL

This Agreement is to serve as a Memorandum of Understanding between Action Network and the Point Arena High School for the term of August 23, 2023 to June 10, 2024.

Action Network may provide the following service hours per week:

- LMFT supervision and coordination of AN staff.
- Two periods of weekly health class lessons for the school year. (Tier 1)
- Social Emotional Learning Coaching. (Tier 2)
- LMFT Behavioral Health Support. (Tier 3)
- Teen Clinic Support.

Both AN and PAHS will:

- In the case of Minor Consent related issues, students 12 and over may self-refer with the help of appropriate Action Network or PAHS staff. All student safety and school check out policies still apply. Students are required to check out and check in at the PAHS Office.
- As needed, Quarterly meetings may be requested and take place between Action Network and PAHS to evaluate services and improve communication or delivery.

PAHS shall:

- Provide relevant demographic data.
- Provide access to teen clinic Monday, Tuesday, 2pm-5pm, Thursdays 2pm-7pm and office hours needed.

PAHS will provide payment to Action Network monthly upon receipt of invoices from AN for the above provided AN services throughout the service time. This MOU shall be effective August 23, 2023, to June 10, 2024, with the total sum for all contracted services for this period \$1,000 per month for approximately for 40 - 50 service hours. Either Party has a right to terminate the MOU upon a 30-day notice to the other party.

This MOU can be changed if merited by time or student need with the agreement of both entities.
