**Section 7: BRIEF REPORTS**

7.1 Student Board Member

**Sidney Regelbrugge, Student Board Member, shared information about volleyball and soccer games, MAP testing, and College and AP classes offered. Students put out a petition to have a voice on the no phones/no personal computers rule (with the exception of use for college courses).**

7.2 Board of Trustees

**Members Visher, Aparicio, and Bechtol reported they attended the Back to School Breakfast and the Arena Back to School Night. Member Visher shared the “Every Day Counts” attendance initiative from Kashia to Manchester Elementary will start up again on October 1. Member Hillscan said the agenda was amended because the board agreed to table item 1.4b from the workshop; and the equity meeting was cancelled due to illness. Member Bechtol appreciated the enthusiasm, informative and inspirational talk at the high school orientation by Principal Feliz. Member Wilder shared her child loves school.**

7.3 Superintendent

**Superintendent Galletti thanked Principal Feliz for implementing the cell phone and personal computer rule for student safety. Galletti reported Charter High is still working on getting their new classroom and Board Policy 6173.4 is on this Agenda for first read and includes the *Five Points for Tribal Sovereignty* curriculum development from Washington State; student outcomes will be discussed at the September 19<sup>th</sup> NAEAC meeting. Dunnell attended a county coastal disaster preparedness meeting yesterday; PAHS is a coastal hub where there is a generator for the gym and cafeteria, water, etc. Galletti continued attendance is crucial and Arena has been hit hard with COVID, and some are out at PA. We hope to avoid full school COVID testing again because it consumes a good amount of staff time.**

7.4 Arena Union Elementary Principal

**Principal Egger shared that 5 teachers plus support staff are out with Covid this week, and remaining staff are covering to make sure student needs are met. Arena finished grades 3-8 MAP testing today and will soon start the “*Elevating Student Voices*” program. For early release professional development today MCOE came and shared “*Universal Design Learning*”, a program to access the learning style and capabilities for all students. Ms. Egger distributed a chart of her CAASPP data for ELA and Math and is disheartened to see low scores.**

7.5 Point Arena High School Principal

**Board Meeting Agenda – October 11, 2023**

Principal Feliz shared information on the 3- Tiered Intervention System, noting the summer pilot tier 2 credit recovery and intervention saw 90% attendance for 14 students who went through target interventions with Carnegie. During the school year Tier 2 credit recovery is asynchronous, offered before/after school and during lunch time. Mr. Feliz reported the personal computer guidelines were modified to accommodate online college courses, 504 students needs, etc. and will be will tracked per county requirements to prevent hacking.

Lillian McFarland distributed a board report from teachers summarizing their classes. She shared the library has changed and they are working with students and leadership to order new furniture, creating usable space in the center. The new curriculum has been helpful for teachers. The College Board congratulated Isaac Cartagena who was awarded National Recognition for his outstanding performance and he was also awarded the National Hispanic Recognition Award and the National Indigenous Award. Ms. McFarland attended a workshop over the summer on teaching holocaust and genocide education. She met members from Redbud Resource Group, an indigenous group from Sonoma County, who have a lot of CA Native American Curriculum and honors local history. Social Studies teacher Shawn McMahan includes indigenous and marginalized cultures in the US in his Ethnic Studies course and would like to present about the class to the board. Drama will perform a one act at the end of October. College representatives will share information with students and parents at “College Night” on September 26<sup>th</sup>.
