# **Section 5: BRIEF REPORTS – 3 Minutes**

# 5.1 Student Board Member - (3 minutes)

Student Board Member Regelbrugge shared the second semester college classes will start on Monday January 22, with *Cultural Anthropology* taught on campus. Music class has started for 5 freshmen and the Theater class spring production will be *Sherlock Holmes*. Student Leadership is planning prom and promoting school spirit. The basketball teams are winning and the Spirit Team is providing support.

# 5.2 Board of Trustees - (3 minutes each)

Bob Gardiner thanked his son Bob, a PAHS alumni, for attending this meeting. Member Gardiner attended a Facility meeting which focused on housing for school staff. Member Bechtol attended the Equity meeting. Member Visher reported EduAct recruited mentors from the community for the Manchester Elementary middle school internship program. All 7 middle school students have mentors matching their interests including engineers, nurses, humane society volunteers, etc. Member Aparicio was at the facility meeting and is interested in the potential housing options with existing buildings.

# 5.3 Arena Union Elementary Principal - (3 minutes)

Principal Egger reported on how Arena is developing their understanding of native peoples and what they are doing to meet the Native American student outcomes. MAP testing started this week, and Dana Ashton, who is a great teacher, has resigned as the 3<sup>rd</sup> grade teacher; Ben Angwin will step in. Mr. Angwin has been subbing and he is knowledgeable and well liked. Staff are participating the RULER Program (SEL) to support student well-being by learning how to regulate their emotions, check in on how they are, and how to be their best self. The program will help the many students who have had traumatic experiences.

#### 5.4 Point Arena High School Principal - (3 minutes)

Principal Feliz shared MAP testing starts next week and remarked the High School History, Social Studies and Ethnic Studies teachers, Ms. McFarland and Mr. McMahon, have been teaching about Native Americans, Tribal Sovereignty, and covering the 5 outcomes prior to them becoming part of our board policy. Mr. McMahon is also teaching from the California Native American Studies Model Curriculum.

# 5.5 Superintendent - (3 minutes)

Superintendent thanked Joseph Swain for stepping in to help with Board Meetings. There are 4 board member site visits scheduled for each school site: PAHS from 9:00 a.m. – 11:00 a.m., on January 25<sup>th</sup>, March 7, April 11 and May 23. Arena visits start at 8:30 a.m. during the isolated reading time on February 8, March 21, April 25 and May 16. An Equity Statement was drafted at the meeting yesterday and will be going out to NAEAC, DELAC, and Site Council. The Facilities Committee met and may consider partnering with the City of Point Arena to use the old South Coast Daycare building for housing. The committee also discussed selling the property behind the high school baseball field to the Tribe, which would streamline the process. Mr. Galletti later met with the Tribal Administrator Tisha Jones and Victor to further discuss the viability.

Lillian McFarland, Student Services Coordinator, History and Drama teacher, distributed a copy of teacher summaries (not all teachers submit reports every month) and noted they are making progress with the yearbook, the Native American Curriculum came from the Redbud Resource Center in Santa Rosa, and Drama class students will perform *Sherlock Holmes*.

Principal Feliz shared a presentation highlighting the CTE goals written in the LCAP and LCFF priorities. Our small school gets college and career data from CALPADS and the administration, office staff, Mr. Swain and Ms. McFarland have compiled additional data which help guide the inclusion of CTE courses into the master schedule. The goal is to provide CTE pathways that meet A-G requirements with starter and capstone classes. Work study/internship bridges CTE and SPED through the "Pirate Café". Mr. Feliz went through the LCAP goals as they relate to CTE and shared the classes offered are C-Stem Tech and Marine Science Tech, Wood Technology I and II, Welding Tech I and II, Auto Tech I and II, Media Arts Technology I and II, Radio Communication Tech I and II and Theater Arts Tech I and II. To ensure PAHS meets the 45% requirement of students graduating career and/or college ready, 91% of 9th graders will get at least 1 CTE class; with second year classes offered 71% of kids will hit the metric.
