Baseline and Growth; results show good growth in math, reading, language and science; 3. District Growth by Quintiles; 4. Baseline Growth by Demographics and 5. English Language Learners.

Business Manager Chin presented the 2023-2024 Second Interim Budget, showing changes in revenue with an overall increase by ~\$13K (0.128%) since the First Interim Budget in December 2023. Expenses decreased by ~\$52K (-0.49%) ending with a lower budget deficit from (\$272,924) to (\$207,772). Multi-year show revenue projected to drop in 2024-25 and 2025-26 due to the one-time funds being expended. Ms. Chin shared the Fund balance remains at a 12% reserve, which meets the State required 4% reserve for Economic Uncertainty. The only change in Fund 17 was transfers in was reduced by \$20K. Ms. Chin cautions we carefully monitor expenditures as there may be a big drop in revenue without one-time funds.
