TRANSPORTATION MEMORANDUM OF UNDERSTANDING
BETWEEN
ARENA UNION ELEMENARY SCHOOL DISTRICT /
POINT ARENA JOINT UNION HIGH SCHOOL DISTRICT
AND
HORICON ELEMENTARY SCHOOL DISTRICT

THIS MEMORANDUM OF UNDERSTANDING AGREEMENT is entered into for the 2024-2025 school year between Horicon Elementary School District and the Arena Union Elementary School District / Point Arena Joint Union High School District hereinafter referred to as “Point Arena”.

WHEREAS, Point Arena will reimburse Horicon Elementary School District at a rate of \$43.00 (\$32.33/hour, plus 33% for payroll benefits) per hour for one-half hour per school day to transport Point Arena students from Annapolis to Gualala in the morning and afternoon. This agreement also notes the addition of a bus stop within Point Arena’s boundaries. Additionally, on days that Horicon is not in session, Horicon will not be responsible for transporting Point Arena students to the high school bus stop.

Total Cost: 170 days @ \$43.00 per hour for 0.50 hours a day = \$3,655.00

TERMS

This agreement becomes effective July 1, 2024, and will continue to June 30, 2025, to be renewed the following school year if both parties agree.

CANCELLATION

This agreement may be canceled by either party upon thirty (30) days written notice by either party.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement to be in effect for the period of July 1, 2024 – June 30, 2025.
