- d. Supporting a district wellness committee to address employee wellness.

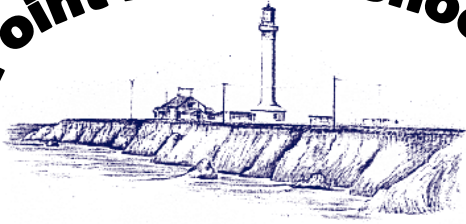
