Variance Explanations (Second Interim vs. First Interim):

- State Revenue (+0.04%): Prop 28 update (+0.4k).
- Local Revenue (+3.67%): higher estimated interest (+12.5k), MCRPD Jr Lifeguard transportation reimbursement (+6k).
- Transfers In (+23.35%): additional technology related expenditures, therefore we transfer in funds from Fund 17 (+25k).

Overall – Total Estimated Revenues increased by ~\$44k (0.425%) since the First Interim Budget Update.

Variance Explanations (Second Interim vs. First Interim):

- Certificated Salaries (+2.28%): Plus two 0.5 FTE partial year positions (+43k); plus additional duty & sub duty estimates (+35k); other employee mid-year updates (-13k).
- Classified Salaries (+2.38%): Plus additional duty & sub duty estimates (+74k); and other employee mid-year updates (-22k).
- Employee Benefits (+0.894%): Fluctuation is in tandem with salary and position changes (+25k).
- Supplies (+3.06%): Added tech related purchases (+49k); reduced estimate curricula based on year-to-date spending (-23k).
- Services/Ops (+6.8%): Added estimated MCOE Psychologist and Nurse costs (+28k); transportation & mechanic services (+28k); athletic travel and services (+10k); higher estimated utilities based on year-to-date trend (+20k); tech related services (+8k); other misc. (+2k).
- Transfers Out (-27.37%): deducted estimated transfer out Deferred Maintenance (-80k); less transfer out to Preschool Fund 12 primarily due to added CA State Preschool Program Cost of Care Plus supplemental amount (-16k).

Overall – Total Estimated Expenses increased by ~\$168k (+1.6%) since the First Interim Budget Update.

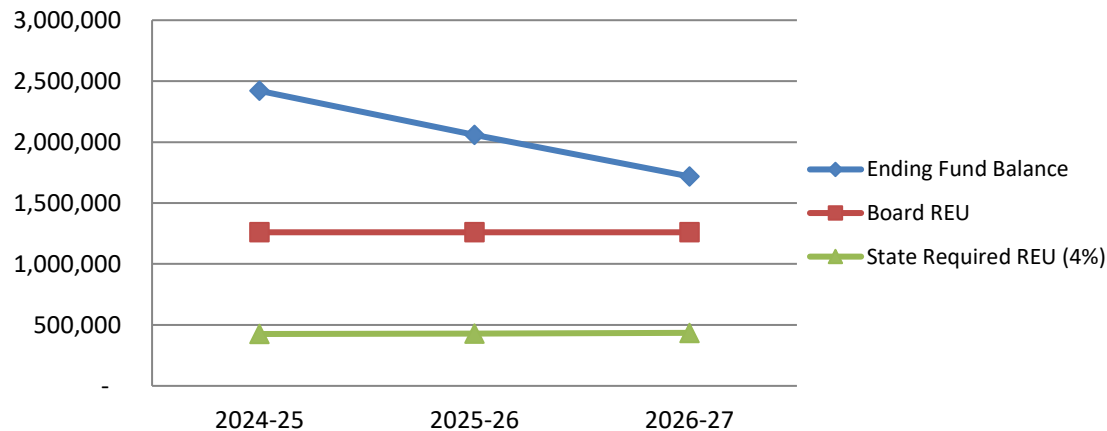

- Local: (25-26) → less MCOE SEL grant (-25k), and less one-time SIGNAL return of net equity (-109k).
- Transfer In: (25-26 and 26-27) → estimate \$30k/yr. of FD17 related tech purchases.
- Cert. Salaries: (25-26 and 26-27) → position adjustments & estimated step increase (~2%).
- Class. Salaries: (25-26 and 26-27) → position adjustments & estimated step increase (~3%).
- Benefits: in tandem with estimated salary changes, plus future STRS and PERS projected updates.
- Books/Supplies: (25-26) → less est. FD17 related tech. (-52k), less Kitchen Infrastructure Grant related (-91k), +2% for inflation; (26-27) → +2% for inflation.

Other Considerations

- This year (2024-25) we are operating without large one-time funds from previous years (ie. in 23-24 ESSER funds (\$365k) and CSI funds (\$150k)), and therefore, must be prudent with spending.
- We should be aware that the 2024-25 Second Interim Common Message, released by the Business & Administration Services Committee, states, *“The state budget faces additional risks due to the result of massive wildfires and federal policy changes, which may impact both revenues and expenditures.”*
- Property tax revenues fluctuate throughout the year – we receive property tax updates from both Mendocino and Sonoma Counties at P-1 (Fall), P-2 (Spring), and Final (Summer).
- Unknown if the type and amount of certain fees will be recurring, which could change current & future year estimates: transfers to other funds (ie. FD 17 – technology; FDs 14/43 – Deferred Maintenance; FD 40 – Facility; FD 15 – Pupil Transportation, etc.).
