6.1 Student Board Member – **Gabriela Aguilar Villagomez shared the Literature club had their first meeting on Monday; they are deciding on books and elected officers, including Gabby as the treasurer.**

6.4 Arena Elementary School Principal – **Principal Egger distributed a copy of the February Beacon and went over Valentines Day plans on Friday; some classes made valentines and distributed them to the seniors at luncheon and sent them with *Meals on Wheels*. The Science Fair is on Friday and Saturday and next week school is out for President's week. During MAP testing there have been students absent with the flu, the *Day Without Immigrants*, and school closure from river flooding. TK-K registration is in March.**

6.5 Point Arena High School Principal – **Principal Feliz reported Tier 3 students (open to all students) used donated funds to take their annual field trip to the DMV and get help with getting their licenses. The Valentine's Day fund raiser has silk roses for sale. Progress reports are out; MAP test growth patterns are good, and people have been out with the flu. The next NAEAC (Native American Education Advisory Committee) is on the 25th at 3:30 and there is a STEM field trip to the Lighthouse. Basketball playoffs are happening.**

6.6 Board of Trustees – **Member Hillscan reported she has been tracking legislation on immigration and ICE status and meeting to have processes in order at each school. Legislation is pending if schools are allowed to alert parents and students when ICE is on campus. Member Mobert asked about our military recruiting policy. Member Aparicio attended a walk through to look at roof leaks and enjoyed visiting Special Ed. and cooking class at the high school. His sister worked for an immigration attorney and she will send information cards on immigrant rights to distribute. Member Martinez also looked at the roof leaks and tennis courts where students play pickle ball. He plans to schedule a time to visit both schools.**

6.7 Superintendent – **Superintendent Galletti shared the focus was on immigration at the DELAC (District English Learner Advisory Committee) meeting; information was shared and a community resource**

space is set up in the high school library. If ICE comes the school, sites will contact the Superintendent's office who will then send a copy of the warrant to School and College Legal Services for review, and schools will notify families if possible. The principals have both put in a tremendous amount of work on LCAPS, Safety Plans, etc. Fire alarms are being worked on at Arena, the heater was fixed in the HS gymnasium and there is a resolution to declare the roofing projects as emergencies. Schools have been closed for 3 storm days; the 2 storm days built into the calendar will now be in school days and we will submit a waiver for the other day.

Section 7: DISCUSSION

7.1 Student Achievement – Semester Grades

- Point Arena High School (5 minutes) –

Principal Feliz distributed extensive Mark Distribution Analysis by Course for 1st Semester 2024-25; Grade Distribution Patterns, Course Performance Highlights, Key Observations, Areas of Improvement, and Recommendations and Next Steps were outlined. The overall average GPA is 3.04.

- Arena Union Elementary (5 minutes)

Principal Egger shared the pass rates for the 74 students in grades 6th – 8th for the first semester of the 2024-2025 School Year: 35 students (47%) earned an A, 18 students (24%) - B, 8 students (11%) - C, 7 students (9%) - D, and 3 students (4%) - F. Overall students are performing well.

7.2 Special Education Report – Marc Feliz (15 minutes)

Principal Feliz, Coordinator of Special Education, presented an in-depth report on Point Arena Schools Special Education program for the 2024-25 School Year: highlighting the structure, services, and related outcomes. Point Arena Schools has 13.6% of students who require Sp. ed. Services, with 20.1 % at Arena Elementary and 10.6% at Point Arena High. The report included Disability Categories, Organizational Charts, Multi-Tiered System of Supports (MTSS), Midyear Benchmarks, and College and Career Indicator.
