4.4 Arena Elementary School Principal – **Principal Egger shared Arena is planning a memorial capsul and fountain in the front garden for Isabella. She reported students have been taking wonderful field trips and she acknowledged the teacher's effort for providing the experiences. The popular Parks and Rec. sponsored Skate nights happen a couple times a month in the MPR are popular. After the NAEAC meeting on 4/25 there will be a taco pot-luck and family math game night. CAASP testing starts 4/29 through May; teachers are happy with the "tools for teachers" website for lessons to help improve CAASP test scores.**

4.5 Point Arena High School Principal – **Principal Feliz reported it is field trip season; students are seeing people who were at the Career Fair out in the community. Students are taking the California Healthy Kids Survey and the CAASP test and teachers are working with the "tools for teachers" to help 9<sup>th</sup> graders taking CAASP. The Prom theme is "Vegas" at the Richardson Ranch on April 26<sup>th</sup>. It's Baseball and Softball season. It's been a somber time as the school is working through grieving. There are plans to put a bench out front and there are printed t-shirts. Action Network and Ruby are working with Donna Miller to offering counseling.**

4.6 Board of Trustees

Member Bechtol appreciated the vibrant and diverse Career Day; he sat in with the Native American Club. Bechtol thanked Mark, who shared Phyllis Wade, Cristin Gash and Diana Valero put the Career Day together. Sigrid shared her t-shirt “Everyone Welcome” and she expressed gratitude for the sites and their supporting each other and the kids during their grief. Mobert, shared a sigh on the loss of the 2 students; he encouraged others to go by the crash site (don’t take kids) to pay respect; people are leaving flowers. Sal went on a field trip to Humboldt- toured the College of the Redwoods campus and Cal Poly Humboldt. There was a “Big Time” with dancers from many tribes and they met Native leaders.

4.7 Superintendent – Superintendent Galletti shared appreciation for the staff at the sites who are keeping things together, building support as our close community goes through losing 2 students. He witnessed the effectiveness of our partnerships with Action Network and RCMS as trusted and known support for our schools. Arena, Point Arena and Charter are taking turns to cover the crosswalk on Hwy 1 near Arena. Galletti told the board we will be reaching out to schedule a workshop before the next board meeting. He asked members to think about the Board Priorities for next year and Sigrid suggested members read the Governance Handbook.

Principal Egger and Middle School Science teacher Cristin Allen want to adopt a new science curriculum, *OpenSciEd* for grades 5-8. Ms. Egger shared a handout about the program. It is based on current standards and focused on UDL strategies where students are curious and figure out how to solve problems. Maya Stewart from MCOE recommends this curriculum.

Principal Feliz shared that with a biochemist and engineer on staff they will move towards project management between the two departments for an integrated model. He shared a handout on the Pearson and Carnegie Integrated Science and Math: Modern Educational Solutions. A Briefing Document shared by Mr. Feliz outlined: I. Shift to Student-Led Learning and Universal Design for Learning, II. Equity and Addressing Learner Needs (WASC Document), III. Focus on Tribal Sovereignty and Local Context, IV. Student Voice and Experience, and V. Strategies for Enhancing Learning and Engagement.
