4.4 Arena Elementary School Principal – Principal Egger shared a handout of the May Monthly Beacon; Arena is providing incentives for CAASP testing that is happening throughout the month. She thanked the board for the *Staff Appreciation Lunch* and shared on May 22 Arena will host an Open House starting at 4:30, with a presentation from the Music class. Ms. Egger invited board members to the Site Council meetings that are in person or available on zoom. Blair Day is on June 6th, June 11th is the awards assembly starting at 8:30 and 8th grade promotion is June 12.

4.5 Point Arena High School Principal – Principal Feliz gave a presentation and explained the "Big Ideas" in Math education and how the Curriculum that is on 30-day display for possible June 11 adoption meets them. Maya, from MCOE, who works with SEL, UDL and Student Voices, will help with the Math and Science framework. Boys Baseball and Girls Softball are going to playoffs. 92% of students are participating in Spring testing.

Member Hillscan talked with Adriana at Tribal Head Start and asked about federal funding; they are good this year; a letter from the board would be helpful. Sigrid enjoyed being on campus for Staff Appreciation. President Martinez reported the board had a good and productive board workshop on Monday with a lot of take aways. He encouraged board members to attend CSBA or other workshops and trainings.

4.7 Superintendent – Superintendent Galletti thanked Lisa for putting together the board workshop; the board priorities discussed will be on the June agenda for adoption and he will meet with the principals to go over the LCAP. Mr. Galletti gave board members a template of the evaluation process for the Superintendent and also a board self-evaluation form. The board will meet in closed session on June 11 to discuss the Superintendent evaluation then it will be complied for approval at the June 25 meeting. Member Dinning arrived at 5:00

Principal Egger spoke on the Counselors and their importance to the CHKS results: Counseling has 3 tiers of student needs: Tier 1 (80 % of students) – the RULER SEL program is offered in K-8 classrooms with Arena Counselor Ms. Binnings, two Action Network employees, and Sal Martinez-Berg. Tier 2 – for students who need a bit more intervention. Tier 3- students who need 1 on 1 counseling. The CHKS participation in 5th grade is up to 96% and middle school is 100%; indicators were not as good as the year back from COVID when students were happy to be back, but there was improvement in connectedness and the scores reflect students feel safe and acknowledged. Life satisfaction and optimism have improved and students scored high on wellness.
