## MEMORANDUM OF UNDERSTANDING BETWEEN ACTION NETWORK AND POINT ARENA JOINT UNION HIGH SCHOOL DISTRICT

This Agreement is to serve as a Memorandum of Understanding between Action Network and the Point Arena Joint Union High School District for the term of August 18, 2025 to June 12, 2026.

Action Network may provide the following services:

- LMFT supervision and coordination of AN staff.
- Two periods of weekly health class lessons for the school year. (Tier 1)
- Support PAJUHSD in improving SEL program. (Tier 1)
- Social Emotional Learning Coaching. (Tier 2)
- 2 periods of drug and addiction groups. (Tier 2)
- LMFT Behavioral Health Support. (Tier 3)
- Teen Clinic Support. (Tier 2,3)

Both AN and PAJUHSD will:

- In the case of Minor Consent related issues, students 12 and over may self-refer with the help of appropriate Action Network or PAJUHSD staff. All student safety and school check out policies apply. Students are required to check out and check in at the PAHS Office.
- As needed, Quarterly meetings may be requested and take place between Action Network and PAJUHSD to evaluate services and improve communication or delivery.

PAJUHSD shall:

• Provide relevant demographic data.

PAJUHSD will provide payment to Action Network monthly upon receipt of invoices from AN for the above provided services throughout the service time. This MOU shall be effective August 18, 2025 to

June 12, 2026, with the total sum for all contracted services for this period \$3,500 per month for approximately 100 service hours. Either Party has a right to terminate the MOU upon a 30-day notice to the other party.
