**REVISED MEMORANDUM OF UNDERSTANDING  
BETWEEN  
ACTION NETWORK  
AND  
ARENA UNION ELEMENTARY SCHOOL DISTRICT**

This Agreement is to serve as a Memorandum of Understanding between Action Network and the Arena Union Elementary School District for the term of August 18, 2025 to June 12, 2026.

Action Network shall provide the following services:

- LMFT supervision and coordination of Action Network staff.
- Social Emotional classroom lessons. (Tier 1)
- Support development of student advisory team. (Tier 1)
- Support development of peer mentoring program. (tier 1,2)
- Social Emotional Learning Coaching. (Tier 2)
- LMFT Behavioral Health Support. (Tier 3)

Both AN and AUESD will:

- In the case of Minor Consent related issues, students 12 and over may self-refer with the help of appropriate AN or AUESD staff. Student safety and school check out policies still apply. Students are required to check out and check in at the AUES Office.
- As needed, Quarterly meetings may be requested and take place between Action Network and AUESD to evaluate services and improve communication or delivery.

AUESD shall:

- Provide payment to Action Network throughout the service period.
- Provide relevant demographic data, including but not limited to age, town, ethnicity, ESL, low income.

AUESD will provide payment to Action Network monthly upon receipt of invoices from AN for the above provided AN services throughout the service time. This MOU shall be effective, August 18, 2025 to June


This MOU can be changed if merited by time or student need with the agreement of both entities.
