

Other Considerations

- We have not received 25-26 P1 property tax estimates from Mendocino & Sonoma Counties – we typically receive this information mid-late November. Based on 24-25 property tax actuals, we would expect 25-26 property tax estimates to increase at P1. Any change as a result of P1 estimate updates, will be reported at First Interim in December 2025.
- Property tax revenues fluctuate throughout the year – we receive property tax updates from both Mendocino & Sonoma Counties at P1 (Fall), P2 (Spring), and Final (Summer).

Part IV - Carry-forward Adjustment

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. The carry-forward adjustment eliminates

the need for LEAs to file amended federal reports when their actual indirect costs vary from the estimated indirect costs on which the approved rate was based.
